Greetings, Brothers of the "Mighty" Second District.

You are invited and welcome to attend the IHQ virtual MSPU Classroom Training via Zoom on Tuesday, September 3, 2024 (**ref. Insert**) However, as in past years, you are still required to attend at a Second District (2D) MSP In-person Training (MIT) session to be "MSP Qualified" to participate in 2D MSP.

This decision requiring 2D MIT attendance is reaffirmed for both the current Fall 2024 MSP cycle, and the Spring and Fall 2025 MSP cycles. Notice of the final dates, times and locations for the 2D MIT sessions will be issued via email notice in September, and also published on the 2D website, Membership Selection page (<https://www.opp2d.org/membership-selection>) along with the portals for you to register in advance.

In the interim, please reference the "MSP Qualified Brothers" list published on the 2D website under the Brother Only tab where you can access the *Membership Selection Resources* page. There you can find the list of MSP Qualified Brothers for Fall 2024 MSP, as well as the MSP Qualified Chapters – they are updated continuously as appropriate. The "MSP Qualified" lists for Spring and Fall 2025 will be published starting in the next Omega Year -- November 1 through October 31 – as qualifications requirements are satisfied by Brothers and Chapters.

If you are not listed as MSP Qualified and you believe you should be, then please FIRST contact your Basileus and/or KRS to determine whether they have all of the information you are responsible to provide them for MSP qualifications processing. Also confer with them to determine whether the chapter has submitted the proper, accurate, and complete information to the Membership Selection Committee (MSC) for consideration. If there is a question regarding a chapters MSP Qualified status, then the Basileus should contact the Membership Selection Committee.
